FDOT to Host Virtual Public Information Meeting

Florida's Turnpike Enterprise to Host Virtual Public Information Meeting for Florida's Turnpike/SR 91 Widening from the Minneola Interchange (mile post 279) to US 27 (mile post 289.3) in Lake County

Ocoee, Fla. – The Florida Department of Transportation (FDOT), Florida's Turnpike Enterprise will hold a Virtual Design Public Information Meeting for the Design project to widen Florida's Turnpike Mainline/State Road (SR) 91 from the Minneola Interchange to US 27 (mile posts 279-289.3) in Lake County, Florida (Financial Project Identification Number: 435786-1).

The meeting will be held on Thursday, August 13, 2020. The meeting will only be available virtually, either online or via a phone connection. Interested persons may participate remotely via computer, tablet, or smartphone with a broadband connection by using a free version of the GoToWebinar online meeting application.
