Good morning Tiffany,

I apologize that I wasn't able to respond sooner. The survey protocol looks good, with a few recommendations:

- Please note that we recommend a 492-foot buffer around active nests even if they are off the project site to avoid take
  - Figure 2 sheet 3 of 3 -- We recommend extending surveys to include the area where the side road will be constructed, especially since the sideroad construction comes close to the utility corridor
- We also recommend extending the vehicular transects to the end of the project (on sheet 3 of 3, we recommend surveying along Norvell Bryant Hwy, going west to follow the edge of the primary corridor line in red)
