

Florida's Turnpike Enterprise Tentative Five-Year Work Program - FY 2022 through FY 2026 Summary of Projects FDOT District Two



DISTRICT TWO PROJECT OVERVIEW

In FY 2020 and FY 2021, Florida's Turnpike Enterprise contributed funding to construct segments of the First Coast Expressway / SR 23 in District Two, totaling over \$464 million:

- East of CR 209 to North of SR 16 (FPN: 422938-5)
- North of SR 16 to North of Blanding Boulevard / SR 21 (FPN: 422938-6)

Florida's Turnpike Enterprise continues to make project investments in District Two. In FY 2022 through FY 2026, Turnpike projects total over \$448 million within Clay and St Johns Counties.

Construct First Coast Expressway / SR 23 – North of SR 16 to North of Blanding Boulevard / **SR 21**

FPN: 422938-6

This project is a partnership project between FDOT District Two and Florida's Turnpike Enterprise that constructs an 11.1-mile segment of the First Coast Expressway from north of SR 16 to north of Blanding Boulevard / SR 21. This segment of the facility is located in Clay County. Construction of the project began in FY 2019 on this \$268M project and the remaining cost to complete the project is reflected in the FY 2025 funding.

This segment of the facility extends across both Clay County and St Johns County. The project is subject to a test of economic feasibility according to Florida Statutes.
