



## Turnpike Extension/SR 821 Widening Project from Dolphin Expressway/SR 836 to NW 106 Street

### Project Description

Florida's Turnpike Enterprise (FTE) is widening the Turnpike Extension/State Road (SR) 821 to 10 lanes, between the Dolphin Expressway/SR 836 and NW 106 Street/Flagler Station Boulevard, in Miami-Dade County.

This project includes the following:

- Widening the Turnpike Extension bridges over SR 836/NW 12 Street, NW 25 Street, NW 41 Street, NW 58 Street, and the NW 74 Street Canal
- Converting NW 117 Avenue, between NW 34 Street and NW 41 Street, into a northbound Turnpike Extension entrance ramp and a slip ramp for local traffic continuing onto NW 117 Avenue, north of NW 41 Street
- Interchange improvements at SR 836 and NW 12 Street, including the construction of three new ramps
- Intersection improvements at NW 12 Street, NW 41 Street and NW 74 Street
- Constructing sound walls along qualifying residential areas adjacent to the Turnpike Extension
- Asphalt milling and resurfacing, guardrail and fencing, lane striping, drainage, signage, and lighting improvements

### Construction and Traffic Impacts

Construction will take place during both daytime and nighttime hours. Nearby residents and businesses may experience periodic construction noise, vibration, and dust. FTE takes steps to reduce construction impacts and efforts will be made to limit traffic and noise disruptions.

Lane closures will generally take place during off peak hours to minimize traffic congestion and delays for most drivers. Closures will be announced in advance in the South Florida and Treasure Coast Weekly Lane Closures and Work Zone Advisory.

#### Schedule and Funding

##### Construction Schedule

Work is anticipated to be completed in 2024.

##### Cost and Funding

The project cost is approximately \$245 million.

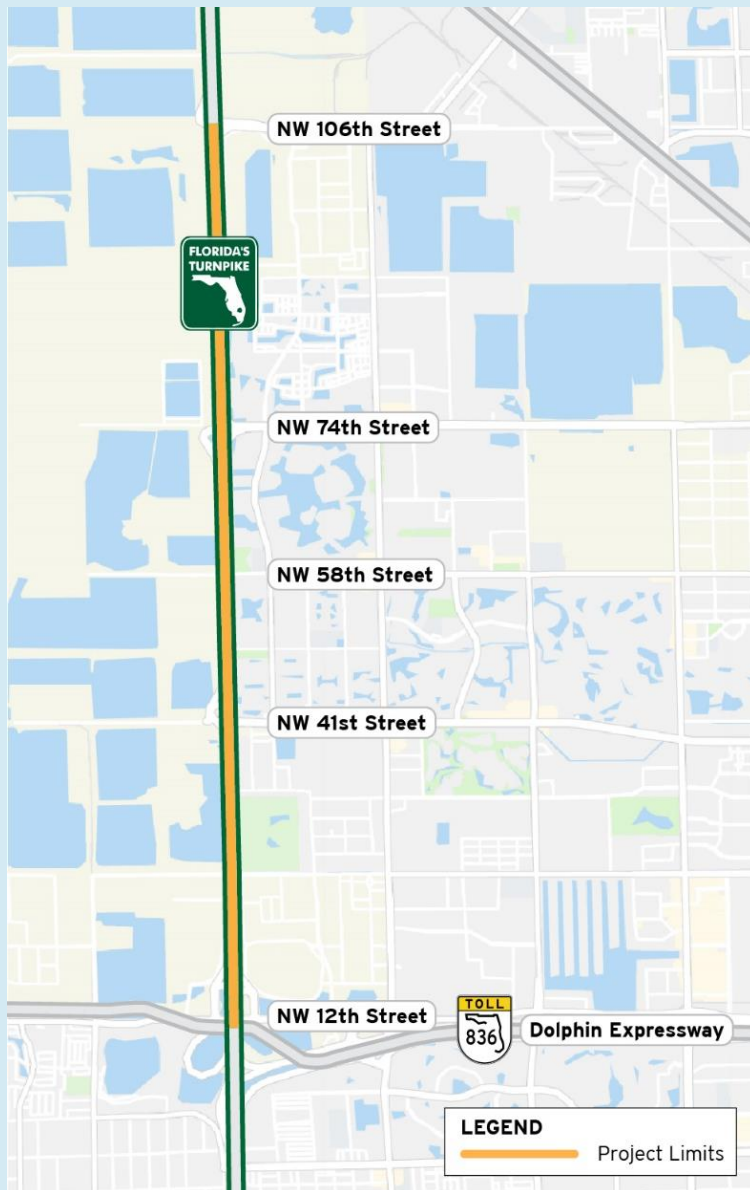
