On Interoperability

- E-ZPass customers can now use their transponder to enjoy seamless travel on nearly 900 miles of toll roads in Florida.
- By enhancing the SunPass system and partnering with E-ZPass, customers using the SunPass PRO can travel toll roads in 18 states along the East Coast and west to Illinois.
- Florida draws 100 million-plus visitors each year because of its wonderful weather and fun attractions, and many visitors have an E-ZPass account. Having E-ZPass accepted on Florida's toll roads makes a lot of sense—and dollars. It is easier to capture a toll transaction when it occurs instead of mailing an invoice, which costs more for customers.
- Accepting E-ZPass on Florida's toll roads is an important step in achieving national interoperability. Interoperability means that a customer who has a prepaid account with one toll agency can travel and have their tolls charged against their account at other toll agencies.

- Toll roads offer convenient routes and time efficiency. The toll system in Florida does not rely on the gas tax, and revenue collected from tolls goes to build, operate and maintain the system as well as service debt on outstanding bonds.
- The revenue collected from tolls helps to deliver critical infrastructure projects for Florida. Those projects provide better roads *and* jobs.
- Collecting tolls electronically increases safety and enhances mobility. Drivers do not need to stop to pay for tolls. Studies show that when the cash option is removed, accidents at toll plazas are reduced by more than 60%.



Introducing the SunPass PRO

- The SunPass PRO[™] works on toll roads and most bridges in Florida plus Delaware, Georgia, Illinois, Indiana, Kentucky, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, North Carolina, Ohio, Pennsylvania, Rhode Island, Virginia, West Virginia and soon Minnesota everywhere E-ZPass is accepted!
- The SunPass PRO[™] Portable Transponder costs \$14.95 plus tax and allows customers to have tolls electronically deducted from a prepaid account. SunPass PRO[™] can be purchased online, by phone, in person or at various retail locations.*
- The existing SunPass transponder will continue to work throughout Florida, Georgia, and North Carolina. Travel on toll facilities in the Northeast or west to Illinois will require a SunPass PRO. Those with a SunPass PRO should not travel with an E-ZPass transponder.
- Having a SunPass PRO means you will always pay the lowest toll rate in Florida. Plus, SunPass PRO can be used to pay for parking at major international airports in Florida, the Hard Rock Stadium in Miami and soon at other locations. It's also ideal for rental cars and motorcycles.
