The webinar will open at 5:30 p.m. with a looping informational video. The formal Public Hearing will begin promptly at 6:00 p.m. followed by the public comment period. 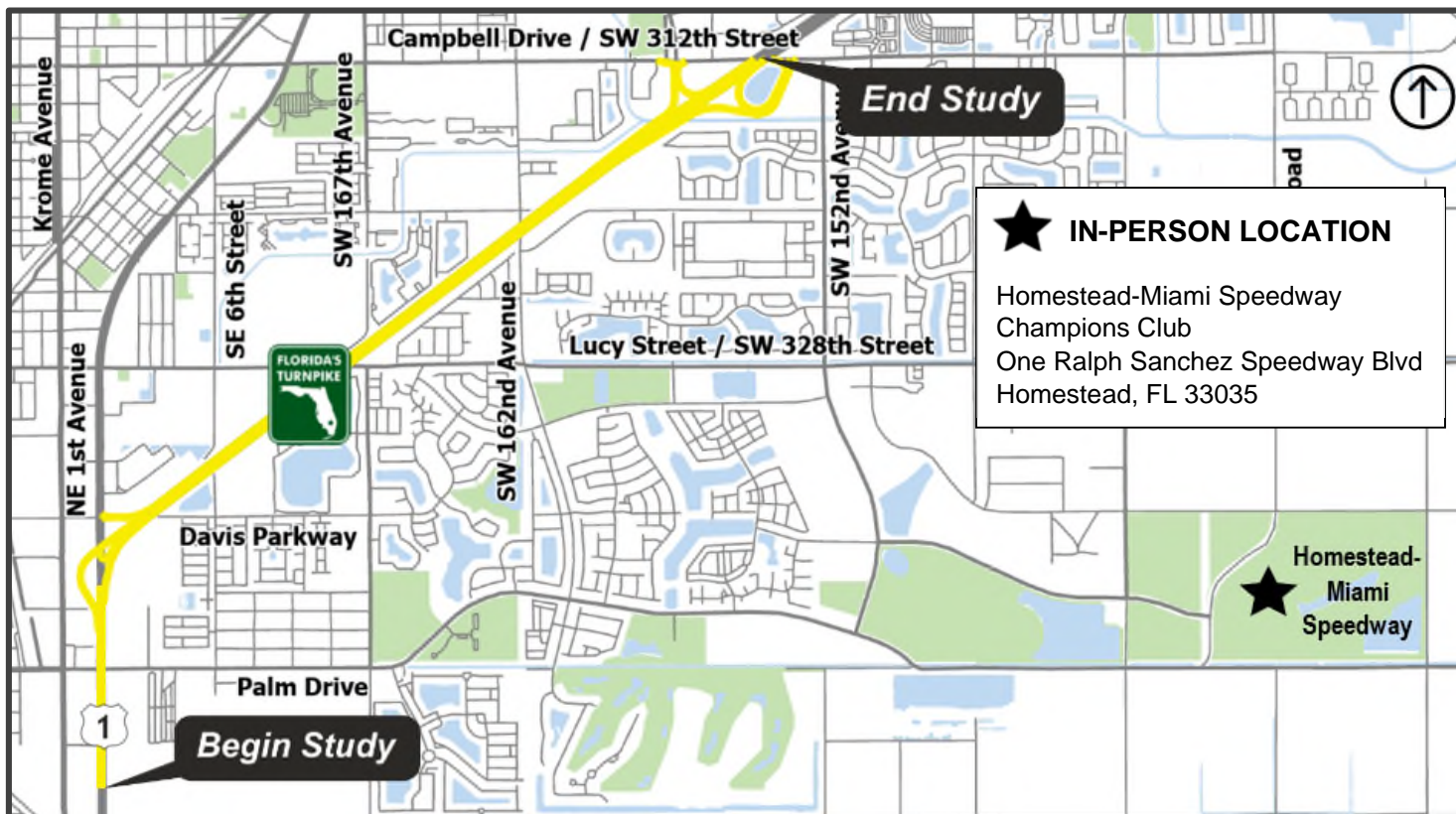

The formal Public Hearing will begin promptly at 6:00 p.m. followed by a public comment period. PROPOSED IMPROVEMENTS

The proposed improvements include the widening of Florida's Turnpike, a Turnpike ramp over the Palm Drive and US 1 intersection, a new partial interchange at Lucy Street/SW 328 Street, as well as access modifications. These improvements are being proposed to enhance safety, address year 2045 traffic needs, enhance emergency evacuation and improve accessibility and mobility.
