



# Florida's Turnpike Enterprise Tentative Five-Year Work Program - FY 2023 through FY 2027 Summary of Projects FDOT District Two



## DISTRICT TWO PROJECT OVERVIEW

Through Fiscal Year 2022, Florida's Turnpike Enterprise has contributed \$442 million in funding to construct the First Coast Expressway / SR 23 from US 98 north of I-10 to east of CR 209, in partnership with District Two.

Florida's Turnpike Enterprise continues to invest in First Coast Expressway / SR 23 in partnership with District Two. In FY 2023 through FY 2027, Turnpike projects with construction funding total over **\$425 million** within Clay and St Johns Counties.

### Summary of Projects

#### FDOT District Two



#### Clay County and St Johns County Projects



#### Construct First Coast Expressway / SR 23 – West of CR 16A to East of CR 209 FPN: 422938-7

This project is a partnership project between FDOT District Two and Florida's Turnpike Enterprise that constructs a 6.5-mile segment of the First Coast Expressway from west of CR 16A to east of CR 209. For the western segment, between SR 16 and east of CR 209, two lanes are being constructed as part of 422938-5 which is currently under construction, while the other two lanes will be constructed with this project. This segment of the facility extends across both Clay County and St Johns County and includes a new bridge which replaces the Shands Bridge over the St Johns River. The project is subject to a test of economic feasibility according to Florida Statutes.

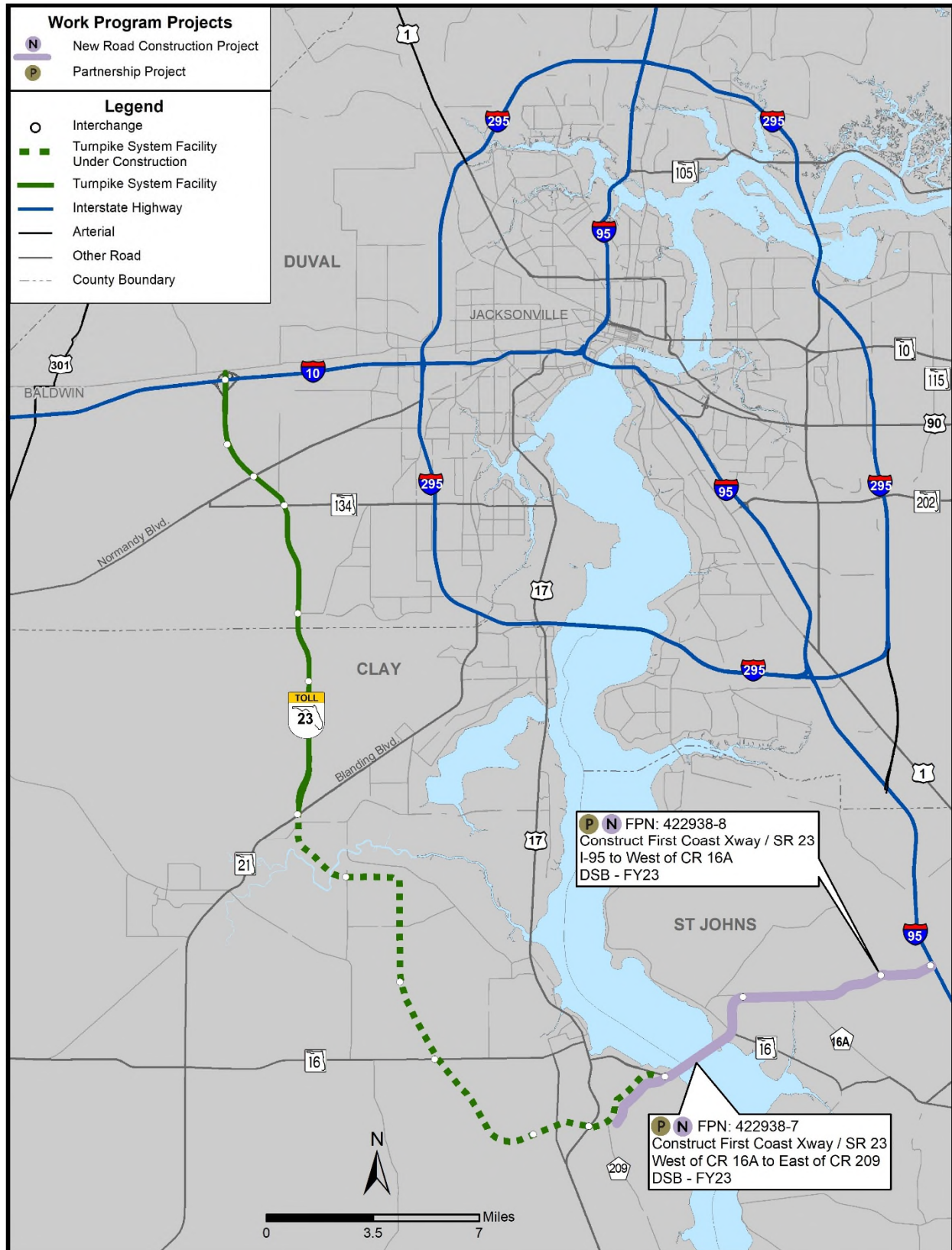
