### DISTRICT ONE PROJECT OVERVIEW

In FY 2021 and FY 2022, Florida's Turnpike Enterprise funded construction of various major transportation infrastructure improvements in District One, totaling over \$48 million. Notable projects include:

### Polk County Projects



#### Construct Central Polk Parkway from the Polk Parkway / SR 570 to US 17 FPN: 440897-2

The project constructs the first segment of the Central Polk Parkway linking the Polk Parkway / SR 570 at Winter Lake Road / SR 540 to US 17. The proposed 6-mile roadway will be a four-lane, divided, limited-access facility that will feature an all-electronic tolling (AET) system. It will reduce commercial vehicle traffic through Bartow, enhance safety by separating regional through-traffic from local traffic, and provide regional connectivity on existing roadways. A second phase of the project will involve extension of the facility to SR 60. The project is subject to a test of economic feasibility according to Florida Statutes.

The project constructs the second segment of the Central Polk Parkway from US 17 to SR 60. The proposed 2.6-mile roadway will be a four-lane, divided, limited-access facility that will feature an all-electronic tolling (AET) system. It will reduce commercial vehicle traffic through Bartow, enhance safety by separating regional through-traffic from local traffic, and provide regional connectivity on existing roadways. The project is subject to a test of economic feasibility according to Florida Statutes.

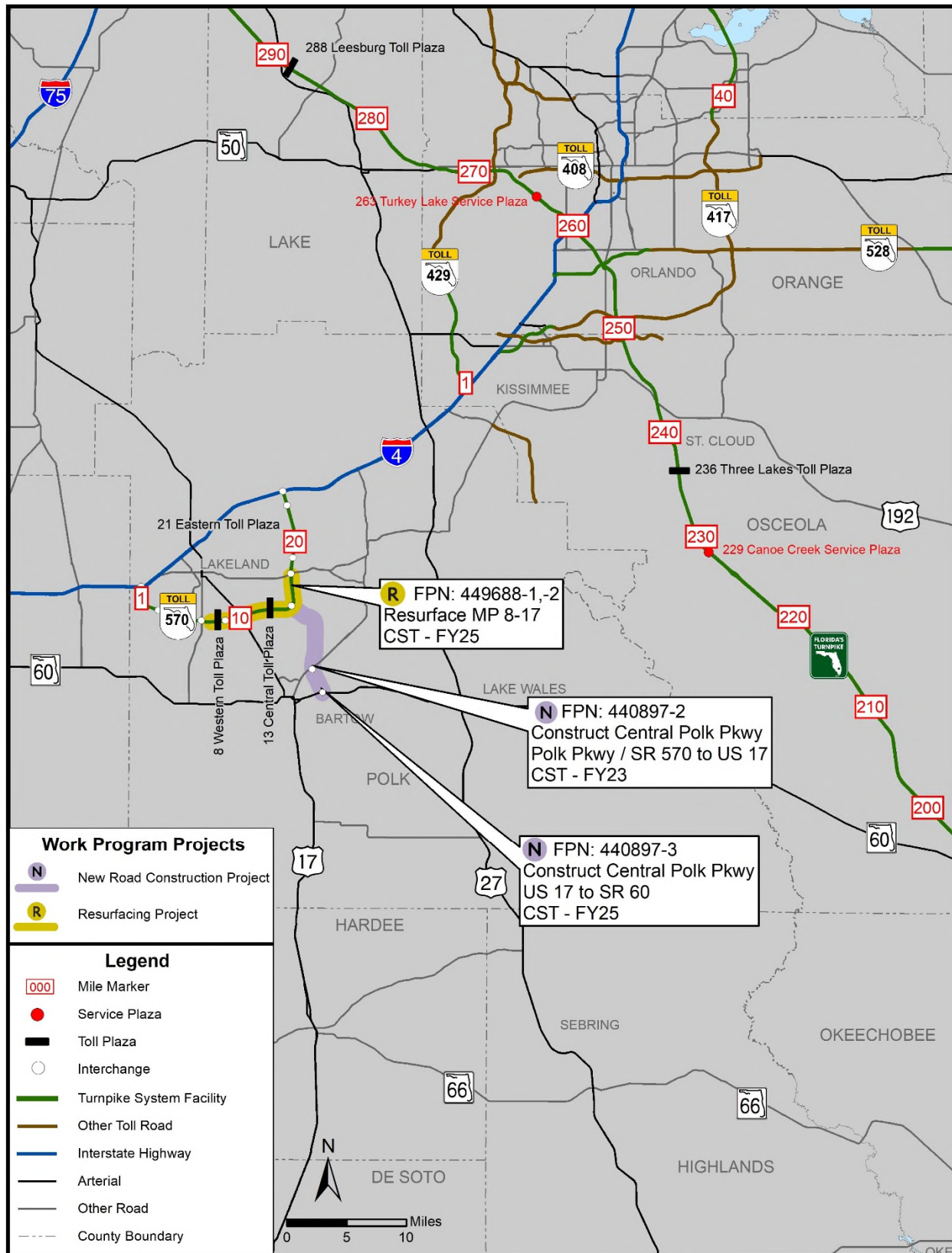
