



# Florida's Turnpike Enterprise Tentative Five-Year Work Program - FY 2023 through FY 2027 Summary of Projects FDOT District Four



## DISTRICT FOUR PROJECT OVERVIEW

In FY 2021 and FY 2022, Florida's Turnpike Enterprise funded construction of various major transportation infrastructure improvements in District Four, totaling over \$95 million. Notable projects include:

Florida's Turnpike Enterprise continues to make significant project investments in District Four. 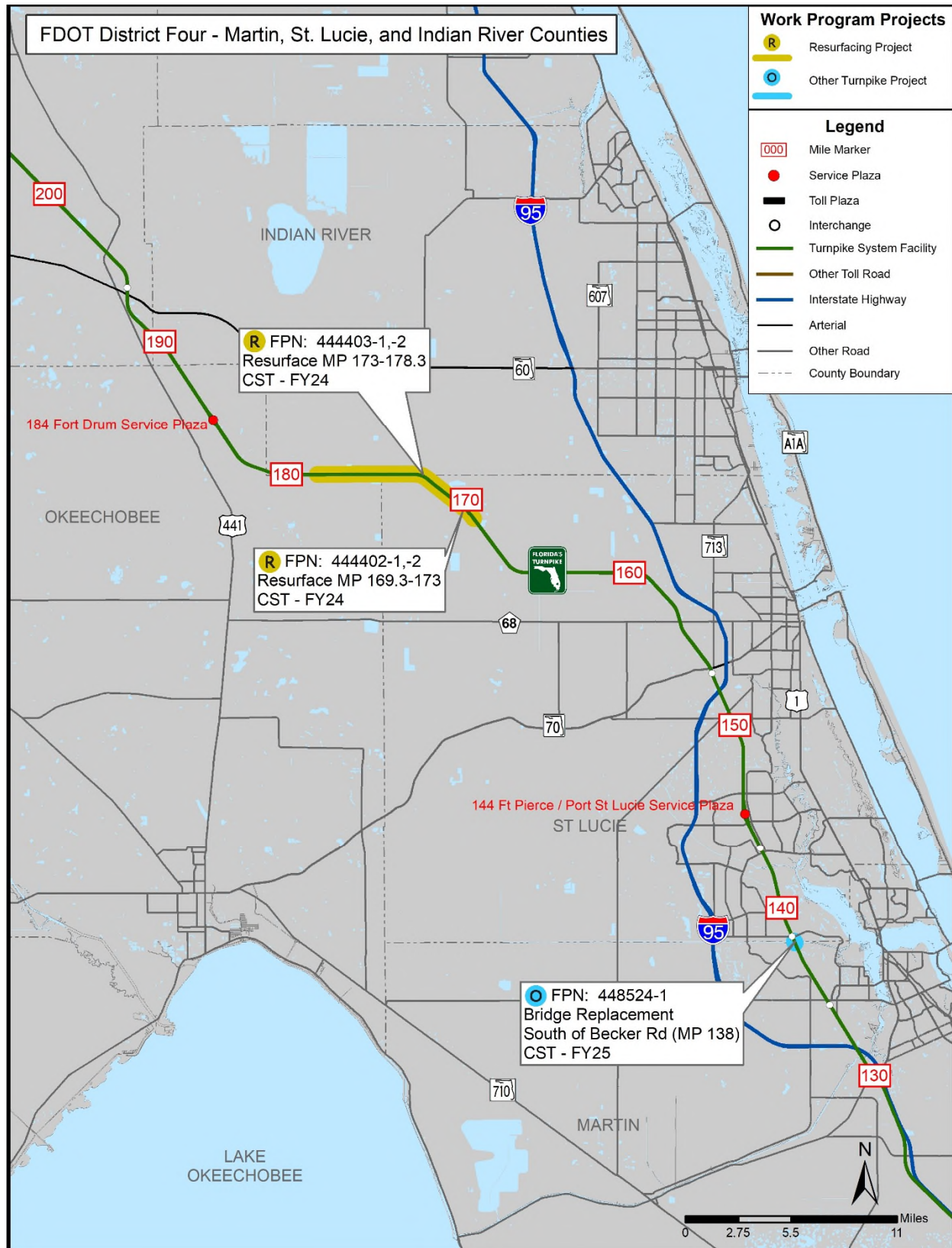

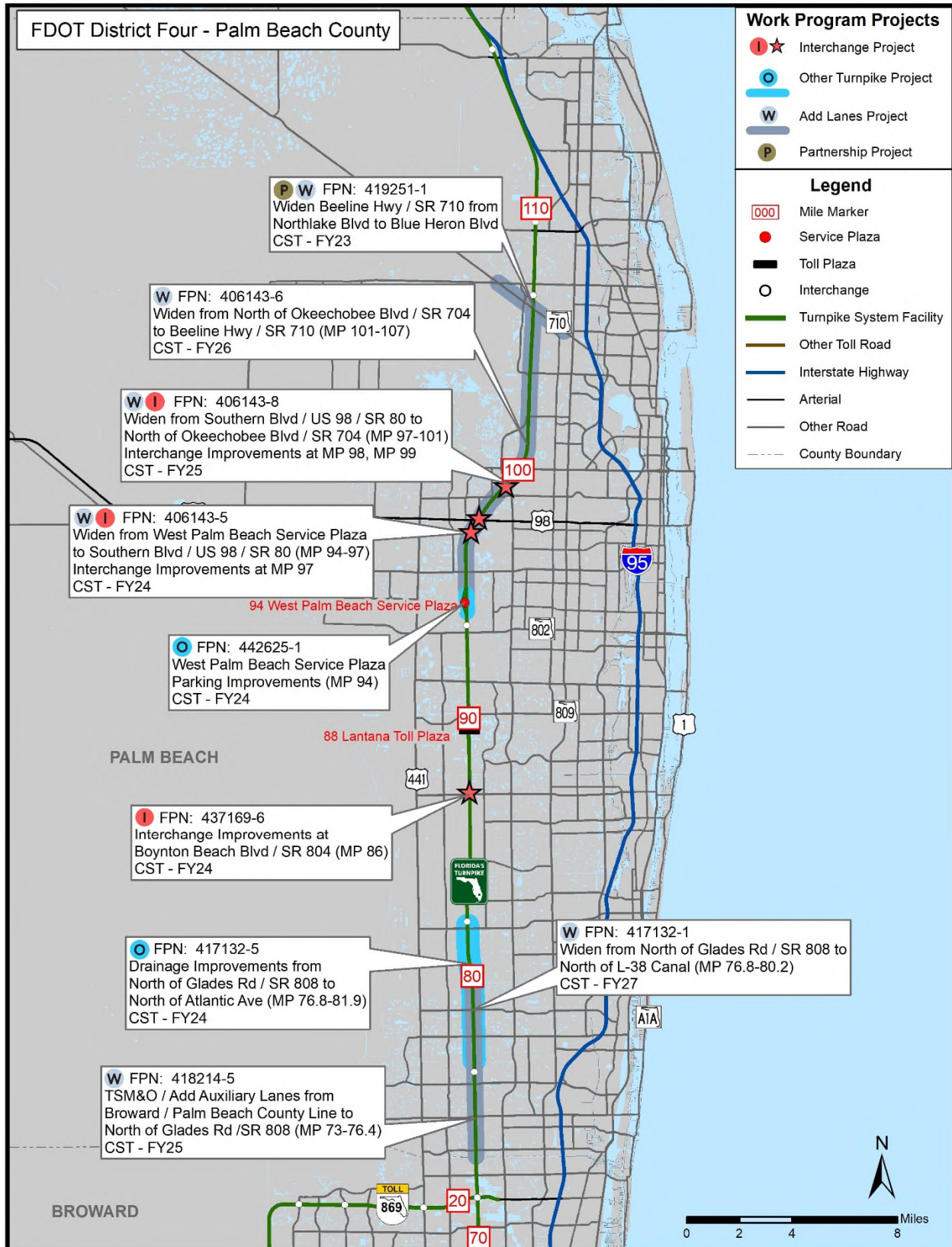

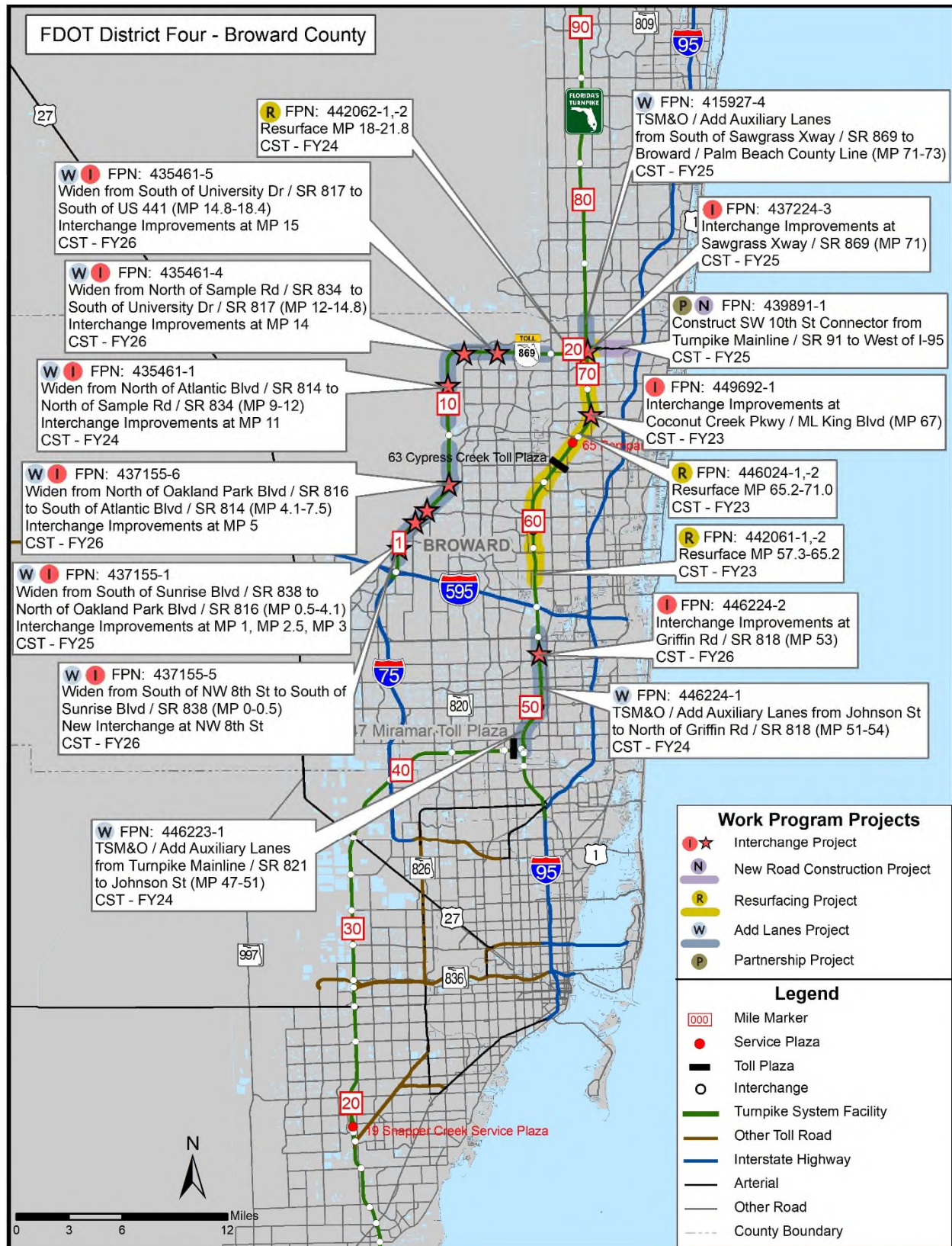
