You are invited to an Alternatives Public Information Meeting for the extension of Poinciana Parkway (SR 538) from County Road (CR) 532 to the Interstate 4 (I-4)/State Road (SR) 429 interchange in Polk and Osceola Counties. There are three participation options to select from:

- By telephone in listen-only mode on February 22, 2022
- In-Person on February 24, 2022

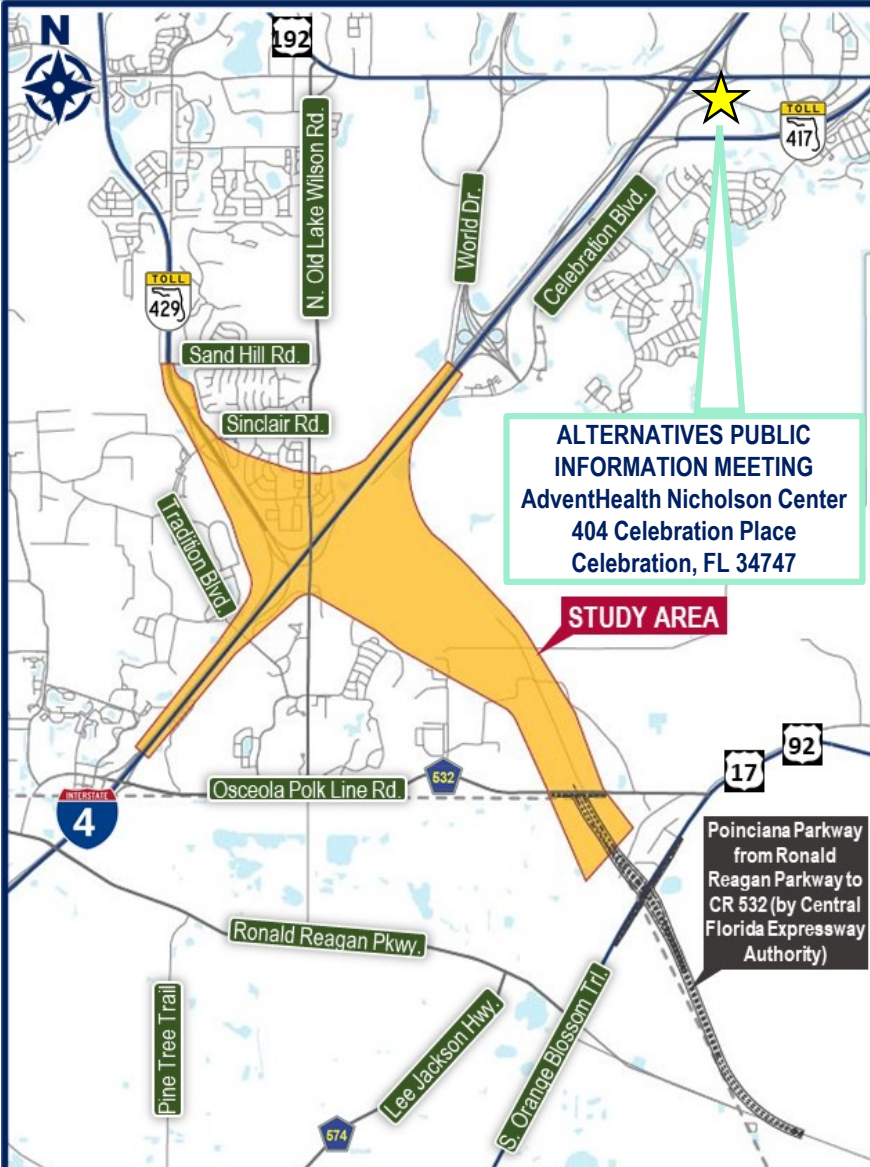

### Proposed Improvements

Proposed improvements include extending Poinciana Parkway from CR 532 to the Interstate 4 (I-4)/SR 429 interchange, modify the I-4/SR 429 interchange to accommodate the Poinciana Parkway connection, and increase the capacity of SR 429 from I-4 to Sinclair Road. This project will provide the missing link in the expressway system between Poinciana Parkway and I-4, improve travel time reliability, and enhance safety.
