

Widen Florida Turnpike (SR 91) from Neptune Road to North of Osceola Parkway

PROJECT OVERVIEW

The Florida Department of Transportation (FDOT), Florida's Turnpike Enterprise, is improving the Florida Turnpike from north of Neptune Road (Milepost 241) to north of East Osceola Parkway (Milepost 249). The purpose of this project is to improve capacity and access along the Florida's Turnpike (SR 91) mainline, interchanges, and cross streets. The Construction phase for the improvements is anticipated to begin in Fiscal Year 2024.


The proposed improvements include widening the roadway from four lanes to eight lanes and adding a median-separating barrier wall. Additional enhancements include a northbound on-ramp, southbound on-ramp and southbound off-ramp at SR 500/US 192/US 441, the replacement of existing bridges crossing the main line, cross-street modifications to accommodate bridge replacements, operational improvements to the Osceola Parkway Interchange, installation of All-Electronic Tolling (AET) structures, signing and pavement markings, Intelligent Transport Systems (ITS) and lighting upgrades, drainage improvements, and noise walls.

The proposed Turnpike mainline configuration consists of four 12-foot lanes, a 10-foot outside shoulder, and a 12-foot inside shoulder in both the northbound and southbound directions. Most of the proposed widening will occur along the inside lanes, with only five feet of widening to the outside lane. Additionally, a concrete barrier wall located in the median will separate opposing lanes of traffic.
