Project Overview



The Florida Department of Transportation (FDOT) Florida's Turnpike Enterprise (FTE) is planning to construct improvements that are designed to accommodate traffic capacity on the Central Polk Parkway and interchanges to meet anticipated traffic demand. These improvements include a new fourlane, limited access toll road with an interchange at US 17, an intersection at SR 60, and a multiuse trail adjacent to the new roadway. This extension of the Central Polk Parkway will

Project Background -

In March 2015, the Polk Transportation Planning Organization (TPO) identified and prioritized an extension of Ernest Smith Blvd. from US 17 (SR 35) to SR 60 in the 2040 Momentum Long-Range Transportation Plan (LRTP) as a new highway. Building on the Polk TPO's plan, FTE began a study in 2018 for the Central Polk Parkway, from US 17 to SR 60. The FTE study ended in August 2021 and identified a Preferred Alternative study concept for the Central Polk Parkway corridor. This Preferred Alternative was a four-lane, limited access toll road with an interchange at US 17,

connect to the section of the Central Polk Parkway project to the north scheduled to begin construction in early 2023, providing a direct connection to I-4 via the Polk Parkway (SR 570). This will reduce travel times to Tampa and Orlando, improve freight movements, and relieve congestion on SR 60 and US 98. The proposed multiuse trail will provide a scenic path overlooking native Florida landscapes that will ultimately connect to the regional trail network.

an intersection at SR 60, and a multiuse trail adjacent to the roadway. In December 2021, the Central Polk Parkway connection between US 17 and SR 60 was included as part of the Polk TPO's Momentum 2045 LRTP. Currently under design, refinements from its Preferred Alternative study concept include an optimized interchange configuration at US 17 and shifting the alignment of the multiuse trail to provide a more intuitive connection to the regional trail network in the future.
