
## **OVERVIEW OF PROJECTS**


The Florida Department of Transportation, Florida's Turnpike Enterprise is proposing to add capacity and improve safety on Florida's Turnpike from State Road 821 to Griffin Road in south-central Broward County. These Transportation Systems Management & Operations (TSM&O) projects add an additional travel lane in each direction by repurposing a portion of the shoulder and widening existing pavement to provide a fourth travel lane both in the northbound and southbound directions. The project will help alleviate current congestion and improve safety and operational issues in this section of the Turnpike.


The project includes construction of noise walls along the right-of-way where reasonable and feasible, as well as improvements to drainage, lighting, signing, and pavement markings. At the Hollywood Boulevard (SR 820) intersection, an additional right turn lane will be added at the exit ramps and a new mast arm traffic signal will be added at the northbound exit ramp. Median revisions along Hollywood Boulevard (SR 820) will be made at the SW 63<sup>rd</sup> Terrace and 62<sup>nd</sup> Avenue intersections. An additional left turn will be provided at 64<sup>th</sup> Avenue. Existing bridges will not be modified.
