
OVERVIEW

Florida Department Transportation (FDOT), Florida's Turnpike Enterprise is proposing to change the Roadway Access Classification on SR 407/Challenger Memorial Parkway between I-95 and SR 405 from Access Class 1 to Access Class 4 in Brevard County, Florida.

The proposed access classification change from Class 1 to Class 4 will allow for new roadway connections to be built intersecting with SR 407 and will allow for additional eastwest access in the area.

BACKGROUND

A new SR 407 connection has been requested that would extend from Grissom Pkwy to SR 407. This new roadway connection is intended to support future Airport Expansion plans and also additional Residential Development in the area.

ACCESS CLASS TYPES

Florida Administrative Code (F.A.C.) 14-97.003 – Access Control Classification and Access Management Standards

Existing Access Classification of Proposal Segment

Class 1: Limited Access facilities do not provide direct property connection allowing for high speed/high volume travel. Requires grade-separated interchange for new access.

Proposed Access Classification of Proposal Segment

Class 4: Facilities on which access is controlled, however these facilities do allow direct access to adjacent lands via the roadway. These facilities also have non-restrictive medians.
