OVERVIEW

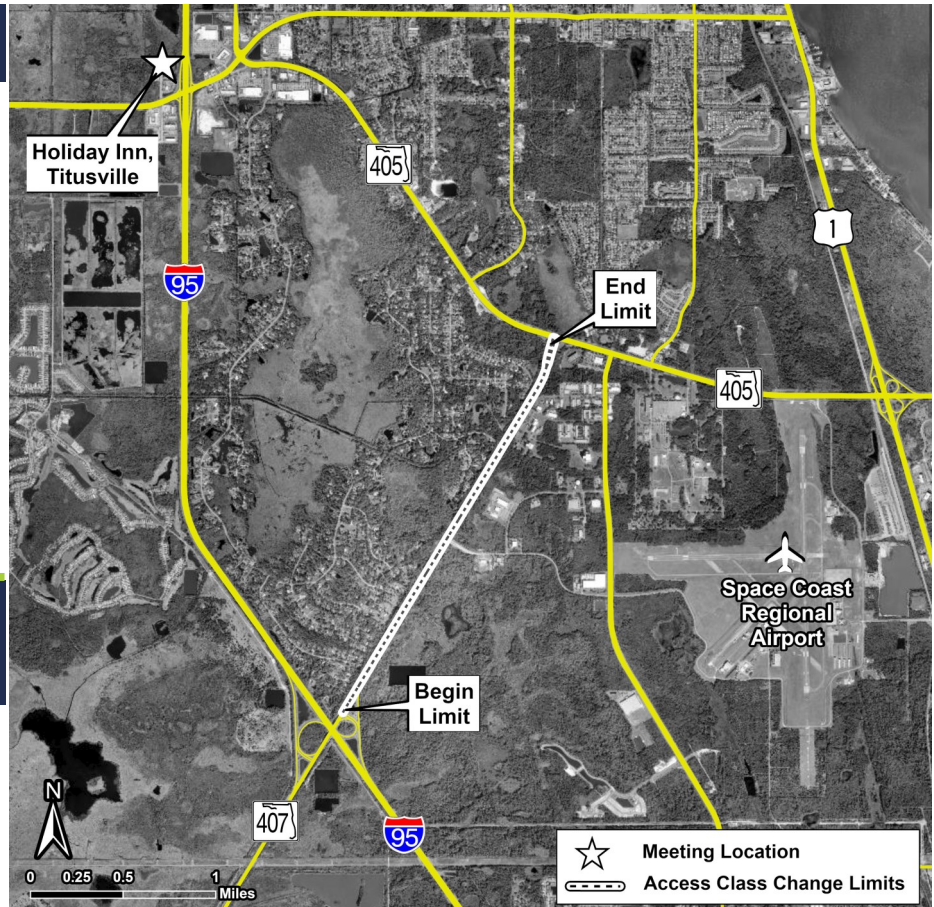
The Florida Department of Transportation, Florida's Turnpike Enterprise is proposing to change the roadway access classification on SR 407/Challenger Memorial Parkway between I-95 and SR 405.

The proposed access classification change is from Access Class 1 to Access Class 4. The proposed change will provide consistency between the roadway characteristics and the roadway access classification type. It will allow for at-grade intersections on the roadway consistent with the proposed access classification.

WHAT IS ACCESS CLASSIFICATION?

A classification of a roadway that determines the spacing standards for:

- Driveways
- Median Openings
- Signals
- Interchanges

ACCESS CLASS TYPES

Access Class 1 Limited Access Facilities

- Allows for high speed/high volume travel
- Does not provide direct property connections
- Requires grade-separated interchanges for new access (Example: I-95)



Access Class 4 Controlled Access Facilities

- Allows direct access to adjacent lands
- Has non-restrictive medians
