#### **PROJECT OVERVIEW**

The Florida Department of Transportation (FDOT), Florida's Turnpike Enterprise is improving the Turnpike in Miami-Dade County, Florida. The purpose of the project is to enhance safety, address roadway and bridge repairs, and improve overall traffic operations at the existing interchanges. The key project improvements are between Hainlin Mill Road (SW 216th Street) and Caribbean Boulevard. Bridge improvements and noise wall installations are included at a few locations from Biscayne Drive (SW 288th Street) to north of US 1 (Dixie Highway).

This meeting will give interested persons an opportunity to review the project design and ask questions about the proposed improvements. Displays that illustrate the proposed improvements will be available at the meeting, along with informational videos. All meeting materials will be available for review the day of the virtual meeting on the project website. Information presented at all attendance options will be the same.

- Northbound Turnpike bridge over Tallahassee Road (SW 137th Avenue)
- Southbound and Northbound Frontage Road bridges over the Black Creek Canal
- Southbound Frontage Road bridge over Canal C-1N between Eureka Drive and Quail Roost Drive
- Northbound Turnpike bridge over the Black Creek Canal

#### Noise Walls at Eight (8) Locations

 Northbound and southbound at mileposts 5.8, 7.5, 7.8, southbound at milepost 10.2, and northbound near milepost 12.
