- All included Technical Special Provisions (TSPs) pages are dual numbered
- The signature block of all included TSPs cover sheets has been reviewed to ensure they meet requirements outlined in **FDOT Specifications Package Preparation Handbook** and **Florida Administrative Code**

## PLANS
