**Notes:**

On November 8, 2021, in conjunction with the All Electronic Tolling conversion of the Turnpike Mainline - SR 91 from MP 88 to MP 236 (i.e., removal of cash collection), toll collection on this section was moved from the ramps to the mainline plazas. Prior to this change, one trip on this facility represented one toll transaction. After the change, the same trip may incur multiple transactions at more than one mainline plaza, contributing to a higher number of transactions at similar toll per trip in effect prior to the change.

Tolls were suspended on central and west central Florida facilities from September 26, 2022 through October 15, 2022 (FY 2023) due to Hurricane Ian, resulting in a revenue loss of approximately \$24.3 million.
