General Project Description and Key Components

437211-1: The proposed improvements for this project are to improve safety and enhance overall traffic operations on this segment of the Turnpike Mainline (SR821) and side streets, as well as bridge rehabilitation within the project limits. This work includes widening of the SB Frontage Road from two to three lanes between Hainlin Mill Rd. and Caribbean Blvd. and the addition of a ramp lane. The project also includes milling and resurfacing the NB direction of the Turnpike Mainline (SR 821) from Cutler Ridge Blvd. to US-1, along with portions of side streets (Hainlin Mill Rd., Caribbean Blvd., Cutler Ridge Blvd. and Eureka Dr.), frontage roads (NB Frontage Road and SB Frontage Road), and ramps (Ramps A, B, C, E, F, H) adjacent to the Turnpike Mainline (SR 821).
