Widen Sawgrass Expressway (SR 869) from North of Sample Road to
West of SR 7 (US 441) in Broward County*

OCOE, Fla. – The Florida Department of Transportation, Florida's Turnpike Enterprise will hold a Design Public Information Meeting for the project or Sawgrass Expressway (SR 869) Widening from North of Sample Road to SR 7 (US 441) in Broward County (Financial Project Identification Numbers: 435461-4 and 435461-5).

The Design Public Information Meeting will be held virtually/online at 12 pm (noon) on April 16, 2024, and the in-person meeting will be held from 5:30 pm – 7:30 pm on April 18, 2024.
