## Notes:

- 1. Tolls were suspended on west central Florida facilities and on a segment of the central Florida Turnpike Mainline from August 29, 2023, through September 5, 2023 (FY 2024) due to Hurricane Idalia, resulting in a revenue loss of approximately \$5.1 million.
- 2. Similarly, tolls were suspended on central and west central Florida facilities from September 26, 2022, through October 15, 2022 (FY 2023) due to Hurricane lan, resulting in a revenue loss of approximately \$24.3 million.
- 3. SunPass, TOLL-BY-PLATE and cash toll rates were indexed Systemwide on July 1, 2023.
- 4. The Garcon Point Bridge was acquired by the Turnpike on February 1, 2024. Accordingly, transactions and toll revenues collected on the bridge are included in the Turnpike monthly transactions and revenues starting this date.
