PROJECT OVERVIEW

The Florida Department of Transportation (FDOT), Florida's Turnpike Enterprise is improving the Turnpike in Miami-Dade County, Florida. The purpose of the project is to enhance safety, address roadway and bridge repairs, and improve overall traffic operations at the existing interchanges. The key project improvements are between Hainlin Mill Road (SW 216th Street) and Caribbean Boulevard. Bridge improvements and noise wall installations are included at a few locations from Moody Drive (SW 268th Street) to north of US 1 (Dixie Highway).

A Design Public Information Meeting was held virtually on April 18, 2023 and in-person on April 20, 2023. The meeting provided interested persons an opportunity to review the project design and ask questions about the proposed improvements. 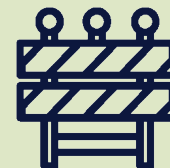

KEY PROJECT IMPROVEMENTS

Interchange improvements

- Widening of Hainlin Mill Road and Cutler Ridge Boulevard under Florida's Turnpike to provide additional thru lanes and left-turn lanes
- Repaving

Bridge improvements

- Widening of the northbound Turnpike bridge over Caribbean Boulevard

Bridge repairs

- Southbound and northbound Turnpike bridges over the Black Creek Canal
- Southbound Frontage Road bridge over Canal C-1N between Eureka Drive and Quail Roost Drive

Noise wall installations

- Northbound and southbound at mileposts 7.5, 7.8, southbound at milepost 10.2, and northbound near milepost 12

DESIGN CHANGES SINCE APRIL 2023

- Maintaining the existing two-lane southbound Frontage Road
- Addition of tubular markers at the southbound Frontage Road on-ramp and southbound Turnpike on-ramp merge area to improve traffic safety
- Inside widening of southbound Frontage Road near Hainlin Mill (SW 216th Street) to add a left-turn lane

These design changes are reflected in the image.
