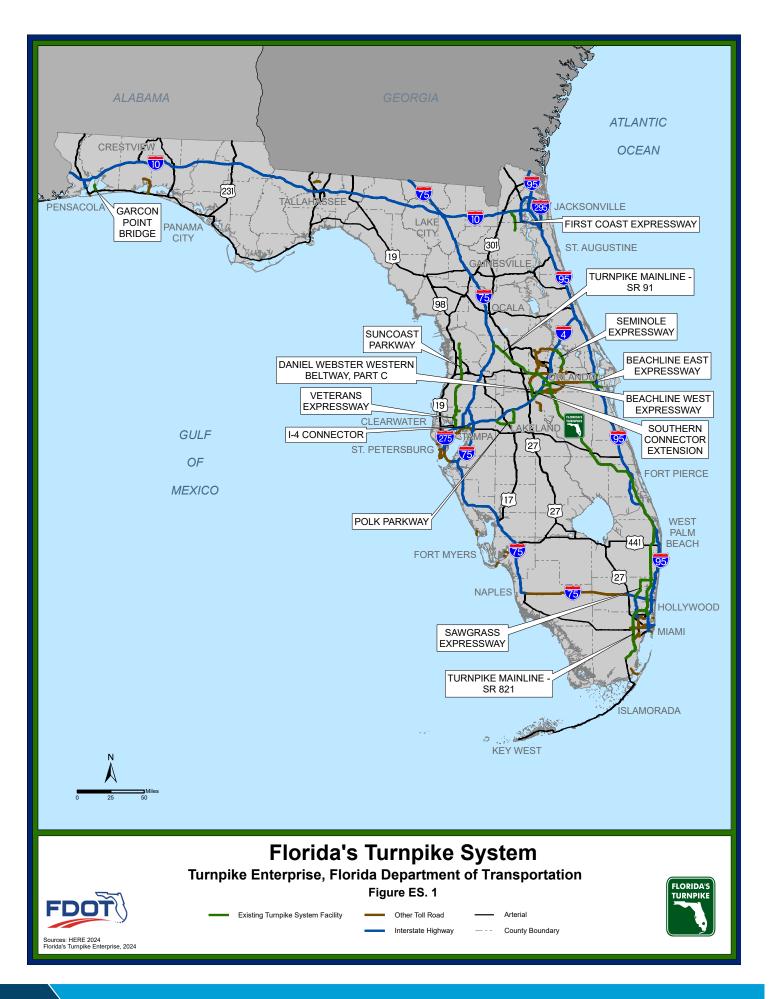
AECOM is pleased to submit this Traffic Engineer's Annual Letter Report on Florida's Turnpike for the fiscal year ended June 30, 2024, in accordance with our role as the Traffic Engineering Consultant for the Florida Turnpike Enterprise. The Turnpike Revenue Bond Resolution, under Section 5.14, requires the Traffic Engineer to annually provide a traffic and earnings report to the Department.

BACKGROUND

Florida's Turnpike Enterprise consists of the Turnpike System, as well as 11 Department-owned and one Department-operated toll facilities in the State. For the purpose of this report, traffic and revenue information for FY 2024 is reported only for those facilities that are part of the Turnpike System (referred to herein interchangeably as "Turnpike" or "Turnpike System"). Similar information for the same period on Department-owned and operated facilities is included in separate reports.

The Turnpike System consists of several components; the principal one is the Mainline with a length of 320 miles. The Mainline includes three segments: the Turnpike Mainline - SR 821, the Turnpike Mainline - SR 91, and the Beachline West Expressway - SR 528. The first two segments of the Mainline are continuous with a north-south direction extending 312 miles from Florida City in southern Miami-Dade County to I-75 at Wildwood in Sumter County to the north. The third segment, the eight-mile Beachline West Expressway, intersects with the Turnpike Mainline - SR 91 in Orlando and has an east-west orientation.

The Turnpike System also includes 11 expansion projects that are currently open to traffic: Sawgrass Expressway in Broward County; Seminole Expressway in Seminole County; Veterans Expressway in Hillsborough County; Southern Connector Extension in Orange and Osceola counties; Polk Parkway in Polk County; Suncoast Parkway in Hillsborough, Pasco, Hernando, and Citrus counties; Western Beltway, Part C in Orange and Osceola counties; the I-4 Connector in Hillsborough County; the Beachline East Expressway in Orange and Brevard counties; the First Coast Expressway in Clay and Duval counties; and the Garcon Point Bridge in Santa Rosa County, which was acquired as a Turnpike expansion project on February 1, 2024. A map of the Turnpike System is presented in **Figure ES.1.**



Executive Summary

FY 2024 Traffic Engineer's Annual Letter Report

FISCAL YEAR 2024 OVERVIEW

Both transactions and revenue increased in FY 2024 for the Turnpike System, as summarized in **Table ES.1.** Total System transactions in FY 2024 increased by 4.1 percent over the same months for FY 2023. There were three primary contributing factors that led to a 4.1 percent growth in transactions: systemwide traffic growth; the Hurricane Ian impact to transactions in the prior year FY 2023; and the introduction of the Garcon Point Bridge as a Turnpike expansion project in February 2024.

The overall FY 2024 Turnpike System revenue was \$1.29 billion, up 14.9 percent from FY 2023 (\$1.12 billion). This revenue increase is due to the systemwide toll rate indexing implemented on July 1, 2023 for all three payment methods (SunPass, TOLL-BY-PLATE, and cash), systemwide traffic growth, and the \$24.3 million Hurricane Ian toll suspension revenue impact in the prior year, offset by the \$5.1 million Hurricane Idalia toll suspension on west and central Florida facilities from August 29, 2023 to September 5, 2023. The breakout of the \$5.1 million revenue loss by facility during the eight-day toll suspension due to Hurricane Idalia (August 29 - September 5, 2023) is summarized in **Table ES.2.** Normalized for the Hurricane Idalia revenue loss, the adjusted FY 2024 actual revenue would be 15.3 percent more than the prior year. With the implementation of systemwide toll rate indexing on July 1, 2023, the total System average toll rate rose to \$0.96, a \$0.09 increase from last year's \$0.87 average toll.

The Turnpike continues to invest in state-of-the-art tolling equipment and prioritize conversion of certain facilities to All Electronic Tolling (AET). This toll collection method eliminates cash toll booths and allows customers to pay tolls electronically while traveling uninterrupted at highway speeds. Electronic tolling at highway speeds increases throughput, shortens travel times, enhances safety and reduces pollution. Customers today experience the benefits of AET on the entire Mainline from Florida City to Wildwood. Specifically, the Turnpike Mainline - SR 821, Turnpike Mainline - SR 91, Suncoast Parkway, Sawgrass Expressway, Veterans Expressway, First Coast Expressway, I-4 Connector, Polk Parkway, and Seminole Expressway which was converted in May 2024, all operate under AET. Over 90 percent of the Turnpike centerline miles are now operating under AET.

A Toll Relief Program, which legislatively appropriated a \$500 million fund to provide toll relief credit to frequent users of all Florida toll facilities, ran from January 1, 2023, to December 31, 2023. This fully reimbursable program had no impact on revenue and no noticeable impact on SunPass transaction volume. On the Turnpike System a total of nearly \$100 million in toll relief credits were issued in FY 2023 (from January through June 2023) and approximately \$107 million in toll credits were issued from July 2023 through December 2023 (FY 2024).

The current 12-month Toll Relief Program which was renewed by the Legislators starting in April 2024 and reimbursed from the legislatively appropriated \$450 million General Revenue Fund, is scheduled to end in March 2025. On the Turnpike System a total of \$108 million in toll relief credits were issued for the six-month period from April through September.

Additionally, the Turnpike provides a convenient and affordable, high-quality customer experience by increasing capacity through widening projects. Key widening projects on the Turnpike System planned in the Work Program include the following:

COMPARISON OF ACTUAL REVENUES TO ESTIMATED REVENUES

Table ES.3 provides a comparison of actual FY 2024 and FY 2023 total revenues. It also shows a comparison of actual and projected FY 2024 total revenue as included in the FY 2023 Annual Letter Report. FY 2024 total revenue of \$1.30 billion (includes \$9 million of concession revenues) represents an increase of \$167 million, or 14.8 percent compared to the preceding fiscal year.

Concession revenues decreased \$355 thousand, or 3.8 percent compared to the preceding fiscal year. The decrease is attributable to a decline in advertisement revenue and non-compliance fines in FY 2023 but not in FY 2024. The concession revenue for FY 2024 was 5.7 percent less than the forecast, primarily due to the non-recurring offset to the advertisement revenue.

The overall increase in Turnpike System revenue is attributed to the implementation of systemwide toll rate indexing on July 1, 2023, and systemwide transaction growth. However, the FY 2024 growth was offset by the toll suspensions related to Hurricane Idalia (\$5.1 million). In comparison, Hurricane Ian resulted in a \$24.3 million revenue loss in FY 2023. Overall, FY 2024 actual toll revenue exceeded the forecast by nearly \$26 million, or 2.0 percent.

TOLL REVENUE FORECAST

In developing the forecast from FY 2025 through FY 2035, historical revenue, unemployment rates, population growth, the most recent trends regarding commuter and commercial traffic, and visitor travel were considered. Additional influences on the forecast include major events such as additional access to the Turnpike System, capacity improvements, conversions to AET, and toll suspensions. Accordingly, impacts to the forecast are summarized on **Table ES.4**.

The revenue forecasts contained in this section are the result of analyses made of the individual segments of the Turnpike System covered in this Annual Letter Report. The forecasts through FY 2035 are detailed by Turnpike System component in order to facilitate monitoring and analysis of each component's performance. Gross toll revenue forecasts for the Mainline and expansion projects are shown in **Table ES.5** and **Table ES.6**, respectively. Forecasts for the total Turnpike System toll and concession revenues are shown in **Table ES.7**.

As mentioned, renewal of the 12-month Toll Relief Program for frequent users of all Florida toll facilities who use Florida-issued transponders is reimbursable from the legislatively appropriated funding source and has no impact on Turnpike toll revenue. This program started at the beginning of April 2024 and is scheduled to end in March 2025.

Similarly, the forecasts reflect revenues from widening on the Turnpike Mainline-SR 91 from Boynton Beach to Lake Worth in FY 2027, and from Lake Worth to SR 710 in FY 2031. Further, the Turnpike Mainline-SR 91 includes the revenue impact from additional auxiliary lane capacity from the Turnpike Mainline-SR 821 to Griffin Road and from Sawgrass Expressway to Glades Road in FY 2030, from Golden Glades to Turnpike Mainline-SR 821 in FY 2033, and from Glades Road to Atlantic Avenue in FY 2034. Also, the forecasts incorporate new interchanges opening on the Turnpike Mainline-SR 821 at NW 170th Street in FY 2027, on the Turnpike Mainline-SR 91 at Leesburg South ramps to/from north, at Sand Lake Road and at Taft Vineland Road ramps to/from the south in FY 2028, FY 2029 and FY 2030, respectively. Additionally, revenues from new interchanges opening on the Turnpike Mainline-SR 91 at Midway Road ramps to/from south are included in FY 2030, at Jog Road ramps to/from the north and in FY 2031, and at Kissimmee-St. Cloud South to/from north ramps, and at Nolte Road in FY 2032, as well as revenues from the Golden Glades interchange modification in FY 2033.

Additionally, the Seminole Expressway forecasts reflect widening revenues from Aloma Avenue to SR 434 in FY 2032. Also, the Sawgrass Expressway forecast includes widening revenues from NW 8th Street to US 441 in FY 2031. Further, revenue from new interchanges opening on the Sawgrass Expressway at NW 8th Street and at Pat Salerno Drive ramps to/from the north in FY 2031 are included in the forecast. Additionally, the forecast includes revenue from the First Coast Expressway Phase 1 extension from Blanding Boulevard to east of CR 209 in FY 2026, and the second segment of the Suncoast Parkway extension between SR 44 and CR 486 in FY 2028.
