Florida's Turnpike Enterprise to Hold Public Information Meeting for Florida's Turnpike Mainline/SR 91 Transportation Systems Management and Operations (TSM&O) Project to Add Lanes from Sawgrass Expressway/SR 869 to Glades Road/SR 808

OCOEE, Fla. – The Florida Department of Transportation, Florida's Turnpike Enterprise will hold a Design Public Information Meeting for the Florida's Turnpike Mainline/SR 91 Transportation Systems Management and Operations (TSM&O) Project to add lanes from Sawgrass Expressway/SR 869 to Glades Road/SR 808 in Broward County (FPID: 415927-4) and Palm Beach County (FPID 418214-5).
