*Florida's Turnpike Enterprise to Hold Public Hearing for the
Widening of SR 91 from North of SR 70 to North of SR 60
in St. Lucie, Indian River, Okeechobee, and Osceola Counties, FL*

OCOEE, Fla. – The Florida Department of Transportation, Florida's Turnpike Enterprise will hold a Public Hearing for the project to **Widen Florida's Turnpike Mainline/SR 91 from north of SR 70 to north of SR 60 in St. Lucie, Indian River, Okeechobee, and Osceola counties.**

The Public Hearing will be held at 6 p.m. on February 18, 2025 (virtual), and at 5:30 p.m. on February 20, 2025 (in-person).

Interested people may participate in the hearing in the following ways:
