for widening Florida's Turnpike Mainline (SR 91) in Palm Beach County*

OCOEE, Fla. – The Florida Department of Transportation, Florida's Turnpike Enterprise will hold a Design Public Information Meeting for the project to Widen Florida's Turnpike Mainline (SR 91) from north of Okeechobee Boulevard (SR 704) to south of Beeline Highway (SR 710) in Palm Beach County, Financial Project Number 406143-6.

The Design Public Information Meeting will be held at 5:30 p.m. on Tuesday, February 25, 2025 (virtual/online) and from 5:30 p.m. to 7:30 p.m. on Thursday, February 27, 2025 (in-person).
