**OCOEE, Fla.** – The Florida Department of Transportation, Florida's Turnpike Enterprise will hold an Alternatives Public Information Meeting for the project to **Widen Florida's Turnpike (SR 91) from north of SR 60 to south of Clay Whaley Road in Osceola County.**

**The Alternatives Public Information Meeting will be held at 6 p.m. on March 4, 2025 (virtual), and at 5:30 p.m. on March 5, 2025 (in-person) and March 11, 2025 (in-person).**
