*Florida's Turnpike Enterprise to Hold Public Hearing for the Project Development & Environment Study for the Widening of Suncoast Parkway from south of Van Dyke Road to SR 52 in Hillsborough and Pasco Counties*

**Ocoee, Fla.** — The Florida Department of Transportation (FDOT), Florida's Turnpike Enterprise will hold a Public Hearing for the **Project Development & Environment (PD&E) Study for the widening of Suncoast Parkway (SR 589) from south of Van Dyke Road to SR 52 in Hillsborough and Pasco counties (Financial Project Identification Number 448068-1).**

**The Public Hearing will be held at 6 p.m. on Tuesday, April 8, 2025 (virtual), and at 5:30 p.m. on Thursday, April 10, 2025 (in-person).**
