
PURPOSE AND NEED


The need for this project is to:

- Relieve congestion from the nearby Hollywood Boulevard and Griffin Road interchanges.
- Provide improved access and system linkage for local and regional travel to and from Florida's Turnpike and Stirling Road.
- Improve mobility options for residents and businesses to keep pace with population growth, economic development, and traffic demand.
- Enhance a key emergency evacuation route.
