The virtual Public Hearing will begin with a formal presentation followed by a public comment period. The in-person Public Hearing will begin with an informal open house, continue with a formal presentation at 6:00 p.m. and conclude with a public comment period. The proposed improvements include the addition of direct connection ramps between Florida's Turnpike and I-95, near Bridge Road (County Road 708). This public hearing is being conducted to give interested persons an opportunity to express their views concerning the location, conceptual design, and social, economic, and environmental effects of the proposed improvements.

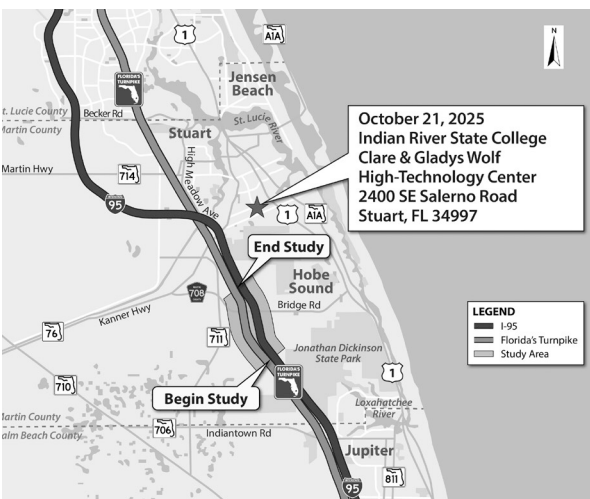

The environmental review, consultation, and other actions required by applicable federal environmental laws for this project are being, or have been, carried out by the FDOT pursuant to 23 U.S.C § 327 and a Memorandum of Understanding dated May 26, 2022, and executed by the Federal Highway Administration (FHWA) and FDOT.
