You are invited to a Public Hearing for the Florida's Turnpike (SR 91) and I-95 Direct Connection Interchange PD&E Study in Martin County. There are three participation options to select from:

This Public Hearing will give interested people an opportunity to review the study, ask questions, and provide comments concerning the conceptual design and potential social, economic, and environmental effects of the proposed improvements.

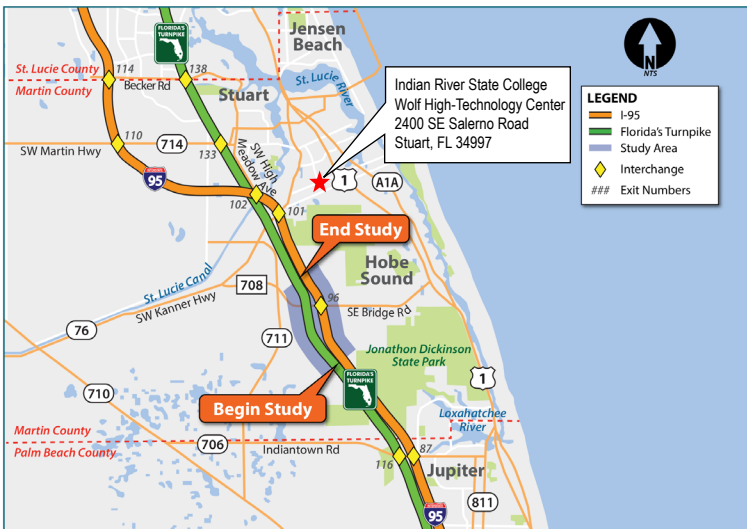

### IN-PERSON OPTION - TUESDAY, OCTOBER 21, 2025 (5:30 p.m. to 7:30 p.m.)

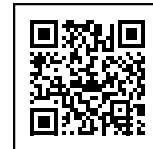

## PUBLIC HEARING MATERIALS

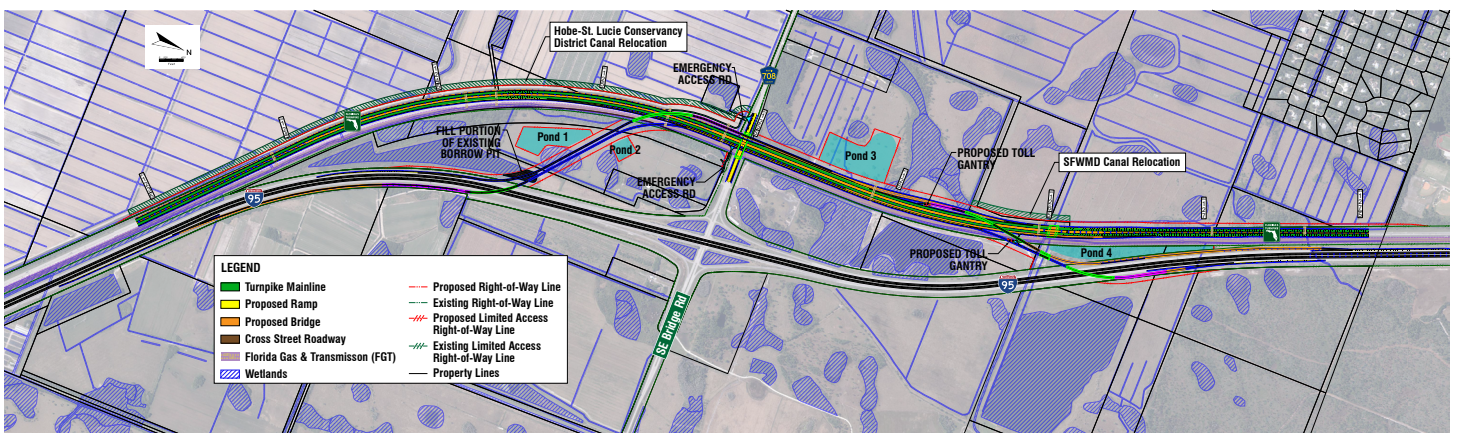

## PROPOSED IMPROVEMENTS

The proposed improvements include a new direct connection interchange between Florida's Turnpike and I-95 near the existing I-95 / Bridge Road interchange in Martin County. New ramps will be added between Florida's Turnpike and I-95 to provide northbound to northbound, and southbound to southbound movements.
