Florida's Turnpike Enterprise to Host a Public Hearing for the Project Development & Environment (PD&E) Study for Florida's Turnpike (SR 91) and I-95 Direct Connection Interchange in Martin County, FL

Ocoee, Fla. — The Florida Department of Transportation (FDOT), Florida's Turnpike Enterprise (Enterprise) will hold a Public Hearing for the **Project Development and Environment (PD&E) Study for Florida's Turnpike (SR 91) and I-95 Interchange Direct Connection Interchange in Martin County (Financial Project Identification Number 446975-1).**

The Public Hearing will be held at 6:00 p.m. on Monday, October 20, 2025 (virtual), and at 5:30 p.m. on Tuesday, October 21, 2025 (in-person).

Interested persons may participate in the Public Hearing in the following ways

The information presented at all attendance options will be the same.

Persons wishing to submit public comments or questions may do so whether attending virtually or at the in-person location. Public comments will be limited to three minutes per person whether given as part of the online format or at the in-person location. Those who are unable to participate in the Public Hearing may submit comments by contacting Project Manager, Jazlyn Georges, using the contact information provided below. All comments received or postmarked by October 31, 2025 will be included in the Public Hearing record.

All hearing materials that will be on display at the in-person hearing, including draft project documents, are available for public review on the project website, www.TPK-I-95-Interchange-Study.com. Draft project documents can also be viewed starting September 29, 2025, through October 31, 2025, at the Robert Morgade Library, 5851 SE Community Drive, Stuart, FL 34997 (Monday, Tuesday, Thursday, Friday and Saturday: 10:00 a.m. to 5:30 p.m.; Wednesday: 12:00 a.m. to 8:00 p.m.; Sunday: closed).
