Florida's Turnpike Enterprise to Host a Public Hearing for the Project Development and Environment (PD&E) Study for Central Polk Parkway East from US 17/92 to Poinciana Connector (SR 538) in Polk County, FL

OCOEE, **Fla.** — The Florida Department of Transportation (FDOT), Florida's Turnpike Enterprise (Enterprise) will hold a Public Hearing for the Project Development and Environment (PD&E) Study for Central Polk Parkway East from US 17/92, south of the Power Line Road extension, to the future Poinciana Connector (SR 538) in Polk County (Financial Project Identification Number 451419-1).

The Public Hearing will be held at 6:00 p.m. on Tuesday, December 2, 2025 (virtual), and at 5:30 p.m. on Thursday, December 4, 2025 (in-person).

Interested persons may participate in the Public Hearing in the following ways:

- 1) Virtually from a computer, tablet, or phone on **Tuesday, December 2, 2025**. Participants attending virtually may join the Public Hearing in listen-only mode by calling 1-415-655-0052 and entering access code 862-825-964 when prompted; or,

Persons wishing to submit public comments or questions may do so whether attending virtually or at the in-person location. Public comments will be limited to three minutes per person whether given as part of the online format or at the in-person location. Those who are unable to participate in the Public Hearing may submit comments by contacting the Project Manager, Jazlyn Georges, P.E., using the contact information provided below. All comments received or postmarked by **December 15, 2025**, will be included in the Public Hearing record.

All hearing materials that will be on display at the in-person hearing, including draft project documents,

Draft project documents will also be available at the in-person meeting location.
