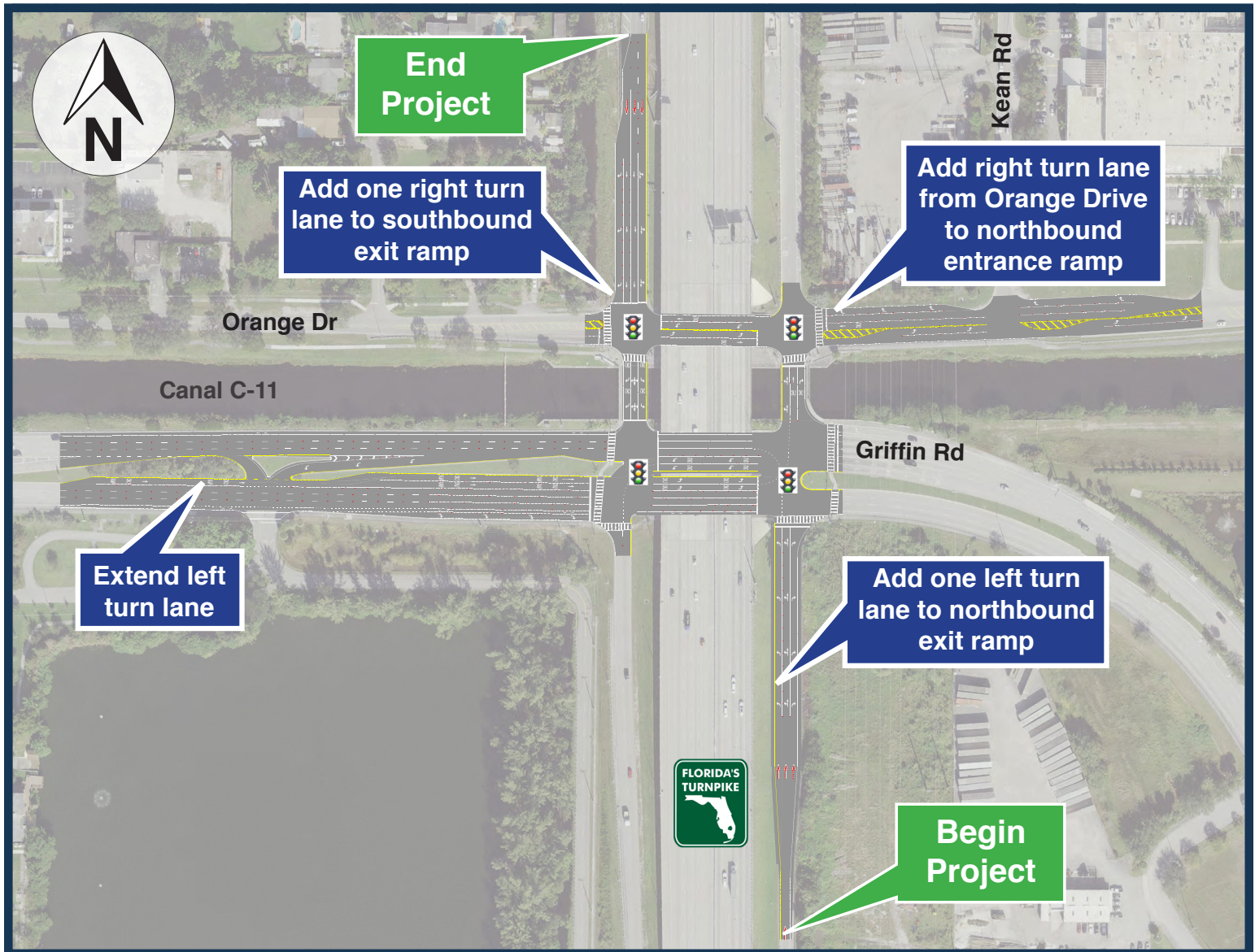

## KEY IMPROVEMENTS

- Widening Turnpike's northbound exit ramp to Griffin Road to provide an additional left turn lane.
- Widening Turnpike's southbound exit ramp to Griffin Road to provide an exclusive right turn lane to Orange Drive.
- Widening Orange Drive in the westbound direction to provide an exclusive right turn lane to Turnpike's northbound entrance ramp.
- Lengthening the left turn lane along Griffin Road in the eastbound direction by an additional 400 feet.
- Milling and resurfacing Turnpike's northbound and southbound ramps as well as Orange Drive and Griffin Road and provide new signing and pavement markings.
- Upgrading the four signalized intersections at the interchange of Turnpike with Griffin Road and Orange Drive to provide new pedestrian signals.
