*Florida's Turnpike Enterprise to Hold Design Public Hearing
to Widen Florida's Turnpike/State Road (S.R.) 91 from North of Glades Road to North of the L-38
Canal in Palm Beach County*

Ocoee, Fla. – The Florida Department of Transportation, Florida's Turnpike Enterprise, will hold a Design Public Hearing for the project Widen Florida's Turnpike/State Road (S.R.) 91 from north of Glades Road to north of the L-38 Canal in Palm Beach County.

The Design Public Hearing will be held at 6:00 p.m. on Wednesday, July 15, 2026 (virtually) and at 5:30 p.m. on Thursday, July 16, 2026 (in-person).

If the in-person Public Hearing cannot be held on Thursday, July 16, 2026, due to severe weather or unforeseen conditions, it will be held on the alternate date of Monday, July 27, 2026, at the same time and place.

Interested people may participate in the hearing in the following ways:
